CC joined the meeting.

The Club has to comply with Minimum Safeguarding requirements from 10/2018, Colin attended a workshop on the 9/7 in his capacity as Club Welfare officer.

The Club has to comply with 5 standards:

- 1. Have a Safeguarding Policy that is clearly communicated to members
- 2. Have a Diversity & Inclusion Policy that is clearly communicated
- 3. Have a Welfare officer who undertakes the necessary training
- 4. Ensure relevant, Volunteers, Coaches and Officers have current DBS Checks
- 5. Have completed an Annual Risk Assessment

DK/RR/CC to ensure policies on the website are updated and compliant and for **RR** to communicate via a separate communication to members. Reminding members CC is the Club Welfare Officer, giving contact details for the LTA team @ Roehampton and to issue a separate 1/4ly reminder to educate parents.

Tennis

- NL formally handed over to CB
- Team updates, Mens A, Mens B and Ladies A all promoted
- School update, CB starts back at Bovingdon Academy on 10/9, on a Monday and Tuesday
- Saturday junior coaching starts on 8/9, CB to communicate to participants and coaches

- Floodlighting, planning application submitted for courts 1 & 2. GB/DK attended Parish Council planning meeting on 8/8, as expected some local resistance, but probable BPC will give support.
- Quotes to overlay courts 1-3 with tarmac, artificial grass or synthetic clay have been obtained. The committee rejected synthetic clay as too expensive but decided to consider additional options:
 - give the club two surfaces
 - create additional capacity (new court 6)
 - remove the existing surface on 1-3 and retarmac

Once all options have been investigated a decision will be made in light of cost and timing, playing requirements, flexibility of use, technical viability and planning considerations. This is part of our long term Club vision.
