### **Planning Application**

A planning application has been received by the club relating to construction of a new 3 bedroom detached house in Green Lane. Access for the development will be via BFTC / Football Club access road. The committee have entered comments relating to this via the Dacorum Planning Website by the required date (11<sup>th</sup> May).

### **Lease Update**

Brabners (LTA recommended legal partners) responded to Council draft promptly. We have yet to hear back from the Council and are actively chasing.



### **Court Cleaning**

All courts have been cleaned and moss removed. There are still residual marks from bird droppings/tennis ball scuffs. To remove these completely would require additional chemical / abrasive cleaning which would entail additional cost and some wear on court surface / colour.

Given that this is cosmetic (all courts are safe to play on), the committee decided not to progress with any further cleaning

#### **Fencing**

Dave and Jill ran through the quote obtained for fencing work to address damage to existing court fencing and improvement of fencing and access. The initial quote came in at a cost of £32, 060.40 (incl. VAT.) Given the size of this expenditure (and mindful of rising costs and inflation generally) the Committee decided to get additional quotes and review at the next meeting

#### Action:

Dave to obtain additional quote and discuss with Jill then bring to next meeting

### **Clubhouse Cleaning**

The Clubhouse has recently been found to be dirty (floors, unwashed crockery, food traces etc) on a number of occasions. We unsurprisingly now have evidence of rodents which we are dealing with. The committee felt that this is likely to continue with the lifting of COVID regulations meaning more food and drinks will be present e.g., post matches. The committee agreed the following:

#### Action:

Jill / Dave to appoint weekly cleaner initially 1.5 hours / week ideally reducing to 1 hour / week Dave to monitor rodent issue

#### **Financial Review**

Dermot ran through the financials for the club for the year to date. The Club is in good financial shape. Revenues are broadly comparable with last year (and much better than 2020). We are entering a period of high inflation which will have a direct impact on all our costs and may have an impact on membership (and revenue) in the future. We will therefore plan to take a cautious approach to any future spending. *Any members wishing to ask any specific questions are encouraged to contact Dermot directly.* 

#### Coaching

We are very close to agreeing a final contract with our new provider (Evolve) and hope to have this in place immediately post half term.

As well as continuing to provide existing coaching blocks (individual and group) we will be looking at the provision of a junior social session, summer holiday junior sessions and potentially cardio tennis (or similar). Steve and Craig are actively planning the start of Club Championships — more to follow soon. Any members who are looking for any specific coaching or have ideas of what they may like to see provided are encouraged to contact Craig directly.

Steve is sourcing a trophy (Plate) for the winners of the inaugural Dot Burgin tournament and there will be a men's and women's trophy for the American Tournaments courtesy of our sponsors (thanks to Dave and Kevin)
