

# **Davenport Lawn Tennis Club**

**GDPR Privacy Policy for Members**

**November 2023**

For the purposes of the General Data Protection Regulation ("GDPR") and UK data protection laws, the controller is Davenport Lawn Tennis Club (the "Venue") of Flowery Field, Woodsmoor, Stockport, SK2 7DR.

## **About this document**

This privacy policy sets out the way we process your personal data and we've created this privacy policy to make sure you are aware of how we use your data as a member of our tennis venue.

## **How we collect your information**

We may collect your personal data in a few limited ways, namely:

- Directly from you, when you fill in an application for membership, when you make enquiries through our website, or when you interact with us during your time as a member in various other ways (for example, where you enter a competition, renew your membership, inform us of a change of address or telephone number, sign up for a course or lessons);
- From someone else who has applied for membership on your behalf (for example a family member or your tennis coach who has provided us with your contact details for that purpose);
- From the LTA (for example, where the LTA passes on your details to us in connection with a complaint or query you have raised about our Venue).
- Photographs/social media – Express consent is requested separately within the 'Application for Membership form'. You or your child will be entitled to withdraw your consent at any time by contacting the DLTC Data Officer. DLTC will take reasonable steps to remove online images from public view. Please note it may not be possible to delete or destroy all images that have been disseminated online (such as via social media) or in hard copy.

## **The types of information we collect**

We may collect the following types of personal data about you:

- Contact and communications information, including your contact details (including name, email address(es), telephone numbers and postal address(es) and records of communications and interactions we have had with you);
- Certain other information which you volunteer when making use of your membership benefits (for example, when making court bookings or making use of other Venue facilities).
- Certain other information required upon commencement of membership (including age, date of birth, gender, category of membership and Emergency contact details).

We may also collect data about your health or medical conditions, where you have volunteered this, for example so that we can provide support or adjustments (if required) when you attend a Venue social event or a course/camp.

## **How we use personal data**

Personal data provided to us will be used for the purposes set out at the time of collection and, where relevant, in accordance with any preferences you express.

More generally, we will use your personal data for the following purposes:

- Administration of your Venue membership, including:
  - informing you about court / facilities opening hours;
  - taking payment of membership fees;
- Fulfilment of orders for goods and services, including court bookings;
- where this is necessary for the performance of a contract (including any written terms and conditions relating to your membership) with you;
- Research and statistical analysis about who is playing tennis in our Venue;
- Communication about our Venue activities that we think may be of interest to you;
- Storing your details on the software platform we use for our Venue member management database. Please note that your own use of the Court booking software or system is subject to the Terms and Conditions and Privacy Policy published on that site;
- where this is necessary for our legitimate interests (for example in increasing use of our Venue's facilities and participation in the game generally);
- Promoting our Venue, events, general information, newsletter and promoting goods and services of third parties (for example, equipment suppliers, operators of coaching courses, and organisers of tennis events) where we think this will be of interest to you;
- where this is necessary for our legitimate interests (or the legitimate interests of a third party), and/or where we have your consent, as applicable.

## **Your marketing preferences**

We will always respect your wishes in respect of what type of communications you want to receive from us and how you want to receive them. There are some communications, however, that we need to send you regardless of your marketing preferences in order for us to fulfil our contractual obligations to you as a member of our Venue. Examples of these essential service communications are:

- Records of transactions, such as payment receipts/membership welcome letters.
- Membership related mailings such as your membership renewal reminder, notices of formal meetings and information about venue closures and holiday opening hours.

## **Sharing your information with others**

We do not sell or share your personal data for other organisations to use other than as set out below.

Personal data collected and processed by us may be shared with the following third parties, where necessary:

- Our employees and volunteers, for the purposes of administering your membership and giving you access to the membership benefits to which you are entitled.
- Our contractors, suppliers and insurers, including coaches, any provider of membership management services. The membership database is held on cloud storage. The members email database is held on a server maintained by our ISP – Freshsites Hosting.
- Other third parties, Clubs or Bodies for the legitimate purposes of permitting members to play in competitive matches/tournaments against other tennis clubs.

## **How long your information is kept**

We keep your personal data only for as long as necessary for each purpose we use it. For most membership data, this means we retain it for so long as you have a valid Venue membership. Any data retained for a longer period will be anonymised.

Personal data collected under H&S legislation will be retained as long as is necessary to comply with the legal obligation and where it is in the legitimate interests of the Club.

## Your rights

Under certain circumstances, by law you have the right to:

- Request access to your personal data (commonly known as a "data subject access request"). This enables you to receive a copy of the personal data we hold about you and to check that we are lawfully processing it.
- Request correction of the personal data that we hold about you. This enables you to have any incomplete or inaccurate information we hold about you corrected.
- Request erasure of your personal data. This enables you to ask us to delete or remove personal data where there is no good reason for us continuing to process it. You also have the right to ask us to delete or remove your personal data where you have exercised your right to object to processing (see below).
- Object to processing of your personal data where we are relying on a legitimate interest (or those of a third party) and there is something about your particular situation which makes you want to object to processing on this ground. You also have the right to object where we are processing your personal data for direct marketing purposes.
- Request the restriction of processing of your personal data. This enables you to ask us to suspend the processing of personal data about you, for example if you want us to establish its accuracy or the reason for processing it. You can also withdraw your consent, where this is the basis for our processing your data (without affecting the lawfulness of our previous processing based on consent).
- Request the transfer of your personal data to another party.

Please note that the above rights are not absolute, and we may be entitled to refuse requests where exceptions apply.
