# **RULES OF THE DERBYSHIRE TENNIS ASSOCIATION**

**As at 1st January, 2024**

1. The name of the Association is the “Derbyshire Tennis Association.”
2. The objects of the Association are:
  - (1) to advance and safeguard the game of Tennis in Derbyshire and to promote increase in participation in all levels of the game of Tennis.
  - (2) to promote the teaching and development of the game of Tennis in Derbyshire and to promote, encourage and support coach education and the training of coaches, teachers, competition organisers, referees and umpires.
  - (3) to represent and express the views of its members at meetings of the Lawn Tennis Association.
  - (4) to keep members informed of any changes in the laws of the game of Tennis or in the regulations for the management of tournaments, inter county championship competitions and to circulate information generally.
  - (5) to promote, arrange and regulate inter-county matches, county championships, tournaments, inter club and junior activities at all levels and age groups and to select representative teams.
  - (6) to do all such things as the Management Committee of the Association thinks fit to achieve the objects set out above.
3. The Association has and will retain a membership interest with the Lawn Tennis Association (hereafter referred to as the “LTA”) and will comply with and uphold throughout Derbyshire the LTA Rules and the LTA Disciplinary Code and the rules and regulations of any person or body to which the LTA is registered or affiliated.
4. The Association shall consist of:
  - (1) tennis clubs, whether they be members’ clubs, proprietary clubs or commercial clubs, who have been granted affiliation of the Association and pays the annual affiliation fee due to the Treasurer of the Association when such fee falls due for payment. A tennis club will only be granted affiliated status provided, that it has a written constitution or set of rules governing its operation, and that it is registered with the LTA as a “place to play” and pays the annual registration fee;
  - (2) the individual members of affiliated clubs who have paid their annual subscription to their club;
  - (3) Associate Members of the Association who have paid the annual subscription for such members to the Treasurer of the Association when such subscription falls due ;
  - (4) organisations who have been granted affiliation to the Association such as, but not limited to, a park-based tennis programme, a school based tennis programme for the community which operates out of curriculum hours, an indoor pay and play tennis centre, a tennis academy, a further or higher education tennis club and/or a tennis league or competition, provided, in each case, that it has a written constitution or set of rules governing its operation;
  - (5) Honorary Life Members of the Association.

5. Any tennis club or organisation which wishes to be affiliated to the Association must submit an application to the Association's Secretary in such form as the Association's Management Committee shall decide. The granting of affiliation shall be in the sole discretion of the Association's Management Committee.
6. Each member of the Association agrees as a condition of membership to be bound by these rules and to be bound by and subject to the LTA Rules and Disciplinary Code and to ensure that its underlying members, any unlicensed and unregistered coaches and, so far as reasonably practical, players using its facilities are bound by and subject to the LTA Rules and Disciplinary Code.
7. The Officers of the Association shall consist of a President, Chairman, Secretary and Treasurer to be elected annually at the Annual General Meeting of the Association. A person shall not be eligible to be elected to be an Officer of the Association if they have previously held such office for an aggregate total of 15 years in the case of the President and 8 years in the case of the Chairman, Secretary and Treasurer.
8. The Association shall be managed by a Management Committee elected under Rule 12.
9. An Annual General Meeting of the Association shall:
  - (1) Be held annually on the fourth Tuesday in November. The meeting shall be convened by the Secretary of the Association giving not less than 7 days written notice of the date, time and place of the meeting to the Secretary or nominated representative of each affiliated club or organisation, the officers and officials of the Association, and the members of the Management Committee.
  - (2) The meeting shall be held at a venue in the county and at a time appointed by the Secretary of the Association.
  - (3) The Notice convening the meeting shall state the business to be considered at the meeting and shall give notice of the nominations received for the officers and officials of the Association, and members of the Management Committee.
  - (4) If for any reason the Annual General Meeting of the Association cannot be held on the fourth Tuesday in November in any year an alternative date shall be chosen by the Secretary of the Association. Not less than 14 days notice of the date, time and place of the meeting shall be given to the secretary or nominated representative of each affiliated club or organisation, the officers and officials of the Association, and members of the Management Committee.
  - (5) The officers and officials of The Association and, members of the Management Committee shall remain in office until the conclusion of the Annual General Meeting at which they retire.
10. An Extraordinary General Meeting of the Association shall be convened by the Secretary of the Association within 28 days of the receipt by the Secretary of a request in writing signed by the Secretaries or nominated representatives of three affiliated clubs or organisations or by three members of the Management Committee. The request shall state the business to be considered at the meeting. Not less than 14 days written notice of the date, time and place of the meeting shall be given to the person entitled to receive notice of the Annual General Meeting pursuant to Rule 9. The notice shall state the business to be considered at the meeting. No other business shall be considered or transacted at such

Extraordinary General Meeting. There shall be annexed to the notice convening the meeting a copy of the request received for such meeting.

11. At any General Meeting or Extraordinary General Meeting the officers and officials of the Association, the members of the Management Committee, any member of an affiliated club or affiliated organisation, any Associate or Life Member shall be entitled to attend the meeting and speak. Voting at such meetings shall be limited to one vote for each affiliated club or affiliated Organisation, each officer and official of the Association, each Life Member of the Association and the representative of the Association on the Council of the Lawn Tennis Association. If any individual person is qualified to exercise two votes or more they shall only be permitted to cast one vote. Proxy votes shall be accepted in accordance with regulations made by the Management Committee as notified to the tennis clubs and organisations affiliated to The Association at least one month prior to any General or Extraordinary General Meeting. Fifteen persons entitled to vote shall form a quorum. Proxy votes shall count in constituting a quorum.
  
12. The Annual General Meeting of the Association convened in accordance with Rule 9 shall elect, if necessary by ballot.
  - (1) The Officers of the Association as set out in Rule 7.
  - (2) The Officials of the Association namely:-
    - (i) the Adults County Team Representative.
    - (ii) the Seniors County Team Representative.
    - (iii) the Juniors County Team Representative.
    - (iv) the Tennis Sub-Committee Chairperson.
    - (v) The County Safeguarding Officer
  - (3) A Management Committee consisting of up to six elected members each of whom must be a member of an Affiliated Club or Organisation. An Affiliated Club or Organisation shall only nominate one person to be an elected member of the Management Committee.
  - (4) Except for the office of President, nominations for each of the Officers and Officials shall be delivered in writing to reach the Secretary of the Association not less than 14 days before the date of the Annual General Meeting. Such nominations shall be signed by a proposer and seconder who must be members of an affiliated club or organisation and by the nominee. Nominations for election to Membership of the Management Committee shall be delivered in writing to reach the Secretary of the Association not less than 14 days before the date of the Annual General Meeting. Such nominations shall be signed by the Chairperson, Secretary or Treasurer of the nominating Club or by the responsible person of the Affiliated Organisation and by the nominee. In the event that there are more nominees for membership than allowed by these Rules, the membership shall be decided by ballot. If there are fewer nominees than places on the Committee, each person shall be elected by the Annual General Meeting. Nomination for the office of President shall be proposed by the management committee.
  - (5) In the event of two or more nominations being received for any Officer or Official resulting in a ballot, the unsuccessful nominees shall, if they wish, be included in the nominations for Membership of the Management Committee provided they are a member of an Affiliated Club or Organisation or a Life Member of the Association and provided their Club or Organisation has not submitted a nomination for Membership of the Management Committee. In the event of that occurring, the Club or

Organisation shall be allowed to determine which of their nominees shall stand for election to the Management Committee.

- (6) In addition to the members elected to the Management Committee under this Rule, the Officers and Officials of the Association elected under Rule 1 above shall be Members of the Management Committee. All members of the management committee must be a member of an affiliated club or organisation or a Life Member of the Association.
  - (7) No Affiliated Club or Organisation shall provide more than three voting members of the Management Committee.
  - (8) In addition to the Members elected to the Management Committee under this rule the Management Committee may co-opt other Members as they see fit in order to carry out the day to day business of the DTA. These co-opted Members shall have no voting rights on the Management Committee.
  - (9) An independent examiner or examiners.
13. In addition to the elections under Rule 12 the Annual General Meeting shall also transact the following business:
- (1) The consideration of the annual report of the Management Committee prepared under Rule 14. This report shall be circulated with the notice convening the meeting.
  - (2) The approval of new rules or the amendment of or addition to any existing rules for interclub championships, leagues, county championships, junior championships and cup competitions as recommended by the Management Committee except for such interclub championships, leagues and cup competitions organised by leagues affiliated to the Association. Any such recommendation shall be served with the notice convening the meeting.
  - (3) The approval of the accounts of the Association prepared under Rule 18. A set of accounts uncertified by the independent examiner shall be circulated with the notice convening the meeting.
  - (4) The fixing of the annual subscriptions for affiliation of clubs and Associate Members payable in accordance with Rule 17.
  - (5) The election to Honorary Life Membership of persons recommended by the Management Committee who have rendered to the County services of outstanding merit. Life members shall have the right to wear the county colour tie and/or scarf.
  - (6) The awarding of county colours to players recommended by the Management Committee who they consider merit the award.
  - (7) The fixing of the maximum sum that can be authorised by the Management Committee to be expended on any one transaction.
  - (8) Consider and if thought fit by resolution, approve the allocation by the Management Committee under Rule 14 of such funds as exceed the permitted limit of expenditure that can be authorised by the Management Committee for any one transaction as fixed by the Annual General Meeting.
  - (9) Consider and if thought fit by resolution take such action against affiliated Clubs or organisations or Associate Members suspended by the Management Committee under Rule 14 including disaffiliation.
  - (10) Determine the rights and privileges from time to time conferred by the Association upon Associate Members.
  - (11) Any other business relating to the objects of the Association. Any business authorised by Rules 9 and 10 to be conducted at an Annual General Meeting may be conducted at an Extraordinary General Meeting convened under Rule 10.

14. The Management Committee shall meet on such dates as are necessary to conduct its business. Six members shall constitute a quorum. Proxy votes shall not be accepted. The Management Committee shall be responsible for:
- (1) The carrying out of the objects of the Association. To fulfil this responsibility the Management Committee may delegate to and contract with such parties as it considers necessary.
  - (2) The allocation of the funds of the Association in such a manner as it considers proper or desirable, subject to no one transaction exceeding the maximum sum fixed by the Annual General Meeting under Rule 13 (8).
  - (3) The preparation and circulation to all affiliated clubs of a summary of the meetings of the Management Committee
  - (4) The preparation of a report for consideration by the Annual General Meeting under Rule 13.
  - (5) The making of such recommendations under Rule 13 as they consider appropriate.
  - (6) Taking whatever action is required or necessary against affiliated clubs or organisations or individual members of such clubs or organisations arising out of any failure to comply with the LTA Rules or Disciplinary Code or any Disciplinary Code issued by the Management Committee pursuant to its responsibility under paragraph (1) of this rule.
  - (7) The election of the Representative or Representatives of the Association to serve on the Council of the Lawn Tennis Association.
  - (8) The Management Committee shall have the power to make, repeal and amend such bylaws as it may from time to time consider necessary for the well being of the Association.
  - (9) The approval or rejection of applications by clubs for affiliation to the Association. Such applications shall be made in writing to the Secretary of the Association.
15. In the event of the failure by the Association at the Annual General Meeting to elect any of the Officers or Officials of the Association or members of the Management Committee or in the event of any of the Officers or Officials of the Association or members of the Management Committee resigning or dying, the Management Committee shall have the power to appoint to fill the vacancy. Notice of any such appointment shall be given to the Secretary of each affiliated Club within 14 days of the appointment being made.
16. The Chairman or President of the Association shall act as Chairman at all meetings of the Association and of the Management Committee. In both their absence from any meeting the members or representatives present shall elect a Chairman. In the event of a tied vote on any issue the Chairman of the meeting shall have a second and casting vote.
17. Each affiliated club or organisation shall pay the annual subscription fixed under rule 13 by 1 April in each year. Each Associate Member shall pay the annual subscription fixed by 1 March in each year.



18. The financial year of the Association shall close on the 31st December in each year and an annual statement of accounts shall be prepared by the Treasurer and duly examined and reported upon by the independent examiner appointed at the previous Annual General Meeting of the Association.
19. The Associate Members of the Association are those persons who pay the annual subscriptions fixed under Rule 13 and such other persons from time to time approved for membership of the Association by the Secretary of the Association. They shall enjoy the rights and privileges conferred upon Associate Members from time to time by the Association under Rule 13.
20. The Derek Wardle Memorial Trophy shall be awarded annually to the most improved junior player over a given season. The Award shall be presented at such Association event as determined by the Secretary of the Association.
21. A resolution to dissolve the Association shall only be proposed at an Extraordinary General Meeting and shall only be passed if carried by a majority of at least three quarters of the members present and entitled to vote.
22. If upon the dissolution of the Association there remains after the satisfaction of all its debts and liabilities, any property whatsoever, the same shall not be paid to or distributed among the Association's affiliated clubs or organisations, but shall be transferred to some other organisation, the objects of which are the same as, or similar to, those of the Association, or to some organisation whose objects are the promotion of charity, and the transfer of such funds approved by Sport England or the body which at the date of dissolution has succeeded Sport England.
23. These rules may be altered or added to at an Annual General Meeting or Extraordinary General Meeting of the Association. At least 14 days notice in writing of a proposed alteration shall be given to the Secretary of the Association. When a proposed alteration is being considered by the Association in General Meeting, it is permissible for an amendment to the proposal to be put forward. If such a proposal is seconded, it shall be voted on and if passed, the proposed alteration shall be amended accordingly before being voted on by the Association."

## **Accounts – Year to 31st December 2023 Treasurer’s Report**

As reported at the AGM on 28<sup>th</sup> November, the method of financing county activities has changed for 2023 and ensuing years. Therefore, the format of supporting notes will have changed to meet LTA requirements. In some cases, there is no meaningful comparison to previous years.

### **General**

#### **Balance Sheet**

1. Bank Balances have increased by £27,449 since 31st December 2022
2. Net Current Assets have increased by £22,402 during the same period due to the above increase.
3. The Tennis Center Sinking Fund has been increased by £14,400 in line with LTA guidance.
4. A Club Support Fund has been generated which according to the new reserves policy should reach £20,000 at some future date. A small value loan system is likely to be rolled out to member clubs sometime after Incorporation.

### **Tennis Center**

#### **Income**

- A. Income of £129,389 was £13,567 higher than in 2022.
- B. This was achieved by higher coaching income and internal use of the facilities such as Junior County Training and Junior Team Tennis.

#### **Expenditure**

- a. Expenditure was £13,556 higher than 2022.
- b. Inflationary pressures have had an adverse effect on employment costs along with additional hours being deployed to reflect the busy nature of the business.
- c. Coaching costs were also significantly higher to service higher demand.
- d. During the final quarter, the aged gas boiler ceased to function. A new modern boiler has been installed at a cost of £6,200.

#### **Net Surplus**

As a result of the above the tennis centre realised a surplus of £16,744 of which £14,400, as previously stated, has been transferred to the Sinking Fund.

### **Central Grant Activity**

As reported at the November AGM, the county now qualifies for a central grant from the LTA amounting to £65,000 per annum with inflationary adjustments for future years. The amount for 2024 is expected to be 5% higher.

The grant covers administration, participation, competitions, and performance. The main costs within that grant include, general admin, website and social media, club and coach support, county cup, tournaments, and junior performance. Derbyshire has approached the project in line with other counties. The whole of the grant has been spent up.

## **Other Association Business**

### **Income**

- A. Reported Income amounted to £13,093.
- B. The county was successful in attracting sponsorship from three donors amounting to £10,750. The first time this has happened since pre-covid.
- C. Interest Rates at the Mansfield Building Society yielded £1,859. An increase of £888 over 2022.

### **Expenditure**

- a. Expenditure amounted to £9,085.
- b. The main components of that expenditure were administration, accountancy, sponsorship support and an advance payment for the 2024 awards night.

### **Net Surplus/Deficit**

As a result of the above, Other Association Business realised a **surplus** of £4,008 during the year which has enabled a Club Support Fund to commence. The aim is to increase that fund to £20,000 as finances permit.

## **The Future**

### **Budgets**

A budget has been prepared and approved by the LTA which plans for an operational surplus of £15,950 and includes the first-year operation of a new Padel Court at the tennis centre. As part of that process a Reserves Policy has been written, also approved by the LTA, and has been posted on the association club spark website.

## The Lawson Wood Cup Rules 2023

1. The President and the Honorary Treasurer of the Derbyshire Lawn Tennis Association shall for all intents and purposes be the legal guardians of the cup in trust of for the Association.
2. The Management of the Competition shall be entrusted to the Secretary of the Competition.
3. Each affiliated club will have the opportunity to enter the Cup Draw. Initial rounds up to the semi finals will be played in a north/south basis as far as reasonably practical, with the top two teams from the north playing against the top two teams from south in the semi finals.
4. Each club may enter one team consisting of six players and forming three couples for mixed doubles, the players being bona fide members of the club, i.e. members who pay in full annual subscriptions and entrance fee. Players who are members of more than one club are not entitled to play for more than one Club in the Competition. There will be no entry fee.
5. The Competition shall be played on the knock-out system. The various rounds are to be played on the given date; the tie may be played on an earlier date with the agreement of both teams.
6. Matches in the rounds up to and including semi-final will consist of nine rubbers. Each rubber shall be two sets with a tie-break played if five games all is reached in either set. Team shall be awarded one point per set won. The team winning the most points (i.e. most sets) shall win the tie. If the overall result is a tie there will be a count-back of games. Should the number of games be equal then one nominated couple from each side will play one deciding set with the tie-break coming into operation at five games all.
7. The Final shall be the best of nine three-set rubbers with a tie-break played if five games all is reached in either of the first two sets. The venue and date for the final to be arranged by the Secretary of the Competition. Any third set will be an advantage set.
8. A club is not bound to play the same team throughout the Competition but no change shall be made in the composition of teams engaged in a tie after the start of play. If a match is postponed before any play shall have taken place the competing teams may be changed.
9. A minimum of two pairs from either side must be on court and ready to play for the match of proceed (within 15 minutes of the appointed start time). Any team sending only one pair will automatically forfeit the match. The match should commence at the start time agreed by the fixtures secretaries/captains, i.e. 6.30pm for a weekday match. If any pair of doubles is not ready to play within ten minutes of the appointed start time (unless by prior agreement between the two clubs), they shall be forfeited if a pair is not ready to play at the end of their next opponents' last set.
10. The club on whose ground the match is being played shall provide not less than three new balls per court of a type and quality approved by the Lawn Tennis Association. Note: The LTA uses the ITF approved list of balls as its approved list. Ball retail containers will usually state if they are LTA/ITF list of balls can be found at [www.itftennis.com](http://www.itftennis.com).

11. The winning team shall send notice of the result in WRITING (email acceptable) WITHIN 48 HOURS OF THE TIE to the Secretary of the Competition. The result to opponents of the teams. If a side receives a walk over from their opponents they must still submit the team they had selected to play the tie to the League Secretary within 48 hours of receiving the walk over.
12. The Cup shall be held by the winning team for one year and the Club will be held responsible for its safe custody.
13. No player (man or woman) who has played for a County Adult Team DURING THE PREVIOUS CALENDAR YEAR shall be eligible to play in the Lawson Wood Cup Competition.
14. A player (man or woman) CANNOT play in the final unless they have played in at least one earlier round unless authorised by the Secretary of the Competition. Any dispute arising between the clubs in the Competition, whether regarding questions or eligibility, qualification of competitors, interpretation of the rules or otherwise, shall be referred to the sole arbitration of the Secretary of the Competition whose decision shall be final.

## Derby Area Tennis League – Summer Rules

1. The Competition shall be administered by the League Committee.
2. Clubs competing in the Competition shall pay the fee for each team entered to the League Secretary at the point when entries are requested.
3. Promotion and relegation in the various divisions shall be automatic – the top two clubs being promoted and the bottom two clubs relegated. An exception to this may arise following either the withdrawal or addition of teams, in which case the number of teams promoted and /or relegated will be at the discretion of the League Committee. If two or more teams in the same division tie on equal numbers of league points (2 points – Win; 1 point - Draw ; 0 points – Loss), for promotion, relegation or the League Championship the highest placed team shall be determined as follows:
  - i) The number of sets for and against over the whole season, for each tied team, shall be determined and the difference between the two figures calculated. The team with the highest positive (or lowest negative - if all are negative) “set difference” shall be awarded the highest league position of the tied teams.
  - ii) If the “set difference” is equal the result(s) between the tied teams shall be used to determine the highest placed team. Sets or games in these fixtures will be added up where necessary.
4.
  - i) No club shall have more than two teams in the same division of the League.
  - ii) A club entering more than one team in a league section shall nominate **SIX** players for each team except the lowest ranked team. In the Mixed section, **THREE** Ladies and **THREE** Men shall be nominated for each team, except the lowest ranked team. **A lower ranked team may only include a maximum of two players nominated for the team ranked immediately above for each match and none from teams ranked higher still. In the event of more than two higher nominated players being inadvertently used, the most successful player(s) shall be deemed ineligible.**
  - iii) Any such nominated player must play **for the team for which they are nominated in at least one of the first two matches.**
  - iv) No player may represent a club in more than TEN matches in one league section in a season i.e. Either Men’s or Ladies or Mixed (as separate entities).
  - v) The League Secretary must receive these nominations in writing not later than 48 hours **after the team plays its 2nd match**. Failure to do so will result in a one point deduction per match played until the nominations are received.
  - vi) If a club has two teams in the same division their first match should be against each other. The match should be played to a conclusion before either team play their next match.
5. A player shall not play for more than one Club in any section (Men’s, Ladies or Mixed) of the competition, and he/she must be a bona fide member, i.e. A member who pays the full annual subscription and entrance fee to the club or clubs for which he/she plays.

6. In divisions where only one match is played between the competing clubs the ground for any match shall be that upon which the corresponding match of the preceding season was not played (where possible). New clubs to a division will take the fixtures of the clubs they have displaced as directed by the League Secretary on behalf of the League Committee.

7. i) All matches shall consist of nine sets – all doubles i.e. each pair shall play three sets (1 set against each of the opposing 3 pairs) . Each set shall be a pro set. The winner shall be the first pair to win 9 games (by 2 clear games) e.g. 9-7. If 8 games all is reached a tie break shall take place. The winner of the tie break will win the set 9-8. For each set won the team shall score one point towards the final match score. If the sets have started, no substitute shall be allowed for players who have already taken part in that particular match.

ii) A minimum of two pairs from either side must be on court and ready to play for the match to proceed (within 15 minutes of the appointed start time). Any team sending only one pair will automatically forfeit the match. The match should commence at the start time agreed by the fixture secretaries/captains. i.e. 6-30pm for a weekday match. If a team has only 2 pairs for the duration of the match, they shall forfeit 3 sets. After that, the following lateness rules apply: If any pair of doubles is not ready to play within fifteen minutes of the appointed start time (unless by prior agreement between the two clubs), they shall forfeit the first 4 games of the first set: if not ready within 30 minutes of the appointed start time they will forfeit the whole set. If 1 hour late they shall forfeit two sets. If one and a half hours later than the appointed start time they will forfeit all three sets.

8. If any club cancels a match, scratches or fails to put in an appearance on the specified date arranged, except by mutual agreement between the clubs concerned the opposing team shall count two points. Inability to raise a full team will not be considered an adequate reason for postponing a fixture. The home team shall decide if weather conditions are fit for play. A team playing with 2 pairs for the duration of a match shall have one (1) point deducted from their total should they win that match.

i) Any club conceding one match for any reason shall have two points deducted from their final total. Any club conceding two matches for any reason will be automatically relegated to the next lower division the following season. Any club conceding three or more matches for any reason will be moved to the lowest division the following season. Clubs conceding three or more matches will have their results in that division expunged.

9. The Match Secretary of a club unable to fulfil a fixture shall inform the Secretary of the opposing club and the League Secretary by letter, email or telephone, at the earliest possible moment.

10. If a match is cancelled owing to bad weather, or other unavoidable cause, it shall be rearranged by the Match Secretaries and/or Team Captains of the clubs concerned within seven days of cancellation. It is the responsibility of the home team to offer a minimum of three dates, giving at least seven days notice, when the opposing team has no fixtures on those dates. Should the home team not offer these dates within seven days, or should the away team not accept any of these dates then the match will be forfeited. The away team to accept within seven days of the offer from the home team. The League Secretary must be notified of the rearranged date by both clubs within 48 hours of agreement.

11. The Captains of the opposing teams shall, if necessary, agree upon umpires who shall see that matches are played out in accordance within the laws of the Lawn Tennis Association.



12. The club on whose ground the match is being played shall provide not less than three new balls per court of a type and quality approved by the Lawn Tennis Association. Note: The LTA uses the ITF approved list of balls as its approved list. Ball retail containers will usually state if they are LTA/ITF approved. If in doubt consult the League Secretary. The approved LTA/ITF list of balls can be found at [www.itftennis.com](http://www.itftennis.com)

13. Before the start of a match it is the responsibility of the home team captain to ask the opposing captain if he wants to start the match afresh or from the score at the point the match is abandoned if the match cannot be completed on the date arranged.

i) If a match reaches the end of the second round or completion of 6 sets (without one team winning 5 of them and therefore the match) i.e. The score at which the match is abandoned shall be the score the match recommences from at a future date/time. (This therefore over-rides the agreement made by the captains at the start of the match).

ii) If the match is not able to progress to the end of the second round (or completion of 6 sets) the agreement made by the two captains at the start of the match shall determine the score to be used when the match recommences on a new date. No agreement made at the start of the match will mean the home captain's preference will prevail if the end of the second round or completion of 6 sets has not been reached.

iii) Where a club has indoor facilities it is the responsibility of the home team captain to ask the opposing captain, before the match starts, if they are agreeable to finishing the match indoors should the need arise.

iv) Where a club has floodlight facilities, these should be used to complete matches when necessary.

14. For each win, a club shall count two league points. In the unlikely event of a match finishing in a draw e.g. if the match is not fully completed and the team captains agree a draw, one league point shall be awarded to each club. The club obtaining the highest number of league points in any section or group shall be the winner thereof.

15. If a team withdraws from the competition before completing its engagements, all records of matches played by the team shall be expunged.

16. The result of every match shall be communicated to the League Secretary within 1 week of it being played, by the home club concerned. The penalty for not doing so is a 1-point deduction.

17. i) The League Secretary shall be responsible for sending out to all competing clubs on the 1st January the fixture lists for all the divisions indicating home and away, together with a list of match secretaries and telephone numbers.

ii) The completed fixtures, in chronological order, must be handed in to the League Secretary at the AGM or by that date.

iii) All league fixtures must be initially scheduled to be played by 15th September. Rearranged matches should be completed by 30th September.

18. Deleted.

19. Any club dissatisfied with any decision of the League Secretary or having any dispute or difference with any other clubs relating to any matter connected with the competition shall

have the right to refer the dissatisfaction to the League Committee for decision. Representatives of the club(s) concerned have the right to be present at the meeting convened to deal with the matter. The decision of the League Committee shall be final.

20. Deleted.

21. These rules may be altered, rescinded or added to at any Annual General Meeting.

## DERBY AREA INDOOR WINTER LEAGUE RULES 2023/24 SEASON

1. The Competition shall be called “The Derby Area Indoor Winter League”.
2. The grouping of the clubs and the running of the Competition shall be in the power of the Derby Area League Committee. Competing clubs shall be affiliated to the D.T.A. or other County Associations.
3. Fixtures shall be made by the Derby Area League Secretary.
4. (i). All matches shall consist of two pairs from each club. Each pair shall play to two short sets, with the tie-break coming into operation at five games all, against each opposing pair. For each set won the team shall be awarded one point towards the final match score. **When the first buzzer sounds, 1 hour 5 minutes into the 2-hour session, any sets still to be completed from the first pairings shall continue playing until an even number of games has been completed. At this point the sets between the 2nd pairings should be commenced. If these sets are completed before the end of the match any incomplete sets from the 1st pairings should be resumed.** When the 2nd buzzer sounds, the point in progress shall be completed and then play is stopped. For incomplete sets, if one team leads by 2 or more games, that team is deemed to have won the set. Otherwise, the set does not count towards the final score. Any incomplete games do not count. If any pair is not ready to play at the appointed time, they shall forfeit the set; if not ready within 30 minutes of the appointed time they shall forfeit two sets.
  - (ii) The team winning the most sets (and therefore) points shall win the tie. A drawn match can result if the number of sets won is equal.
5. (i) A player shall not in any one season play for more than one club in any section (Men’s, Ladies or Mixed) of the competition and he/she must be a bona fide member – i.e. a member who pays the full annual subscription or a ‘summer only’ subscription of the club or clubs for which he/she plays.
  - (ii) Players are considered to play for only one team in the same competition in the same season. i.e. a player can play for Men’s 1 only not for Men’s 2 or 3 in the same indoor season. However, a player from a lower team may play one (1) match only for a higher team. To clarify, a player who has played twice for a higher team cannot then play for a lower team; a player who has played once for a higher team and once for a lower team can only subsequently play for the lower team.
6. (i) If any club cancels a match, scratches or fails to put in an appearance on the specified date arranged, the opposing team shall count a win. Inability to raise a full team will not be considered an adequate reason for not fulfilling a fixture. In the event of a cancellation the Venue Manager must be informed immediately
  - (ii) If cancellation occurs less than 48 hours before a match is due to begin, the defaulting club shall be required to pay the total court fee (excluding the cost of balls) **In the event of no notification being given at all prior to the match then the cost of the balls will be included** and the team and shall not be permitted to compete further in the Competition until all such fees are paid.
  - (iii) If cancellation occurs more than 48 hours before a match is due to begin, the defaulting club shall be required to pay 50% of the total court fee (i.e. excluding the cost of balls) and shall not be allowed to compete further in the Competition until all such fees are paid.

**(iv) If a team fields only one pair, then their opponents are only charged half of the usual match fee. The team with one pair is liable to pay their own fees and half the fees of their opponents.**

7. Any club conceding one match for any reason shall have two points deducted from their final total. Any club conceding two matches for any reason will be automatically relegated to the next lower division the following season. Any club conceding three or more matches for any reason will be moved to the lowest division the following season. Clubs conceding three or more matches will have their results in that division expunged.
8. If a club shall withdraw from the Competition before completing its engagements, all records of matches played by the club shall be expunged.
9. Promotion and relegation in the various divisions shall be automatic – the top club being promoted and the bottom club being relegated. An exception may arise following either the withdrawal or addition of teams, in which case the number of teams promoted and/or relegated will be at the discretion of the League Committee. If two or more teams in the same division are tied on points (2 point – Win, 1 point - Draw, 0 points - Loss), the team with the highest positive (or lowest negative) set difference when calculated over all matches played will finish in the higher league position. If the set difference is equal the result of the fixture between the tied teams shall be used to determine the highest finishing team. Sets or games in these fixtures shall be added up where necessary.
10. An inclusive charge per team to cover the court fee and provision of balls shall be determined by the League Committee and Venue Manager and shall be paid before the commencement of play.
11. Clubs shall pay a fee for each team entered, the amount as determined at the A.G.M. of the Derby Area League. This shall be £5 per team for 2023/24.
12. The match score (as one point per set), result and names of the competing players shall be entered on a scorecard and communicated to the League secretary within 48 hours of the match being played. This must be signed by the captains of each team.
13. A ball striking the roof or other court fixture shall be deemed to be a fault.
14. Players will only change ends at the completion of a set.
15. Non-marking white-soled tennis shoes only to be worn.
16. If on the 30th April in any year there is a list of clubs waiting to enter any of the three Competitions, the club at the top of the list(s) shall be admitted to the Competition and the displaced club(s) at the bottom of the league(s) shall move to the bottom of the waiting list(s).
17. All differences and disputes shall be referred to and settled by the League Committee. Particulars shall be sent in writing within three days to the League Secretary by the Secretary or Secretaries of the club or clubs concerned who shall have the right to be represented at the meeting convened to deal with the matter. The decision of the League Committee shall be final.
18. For breach of any of these rules, and for any irregularity, the League Committee may impose such penalties – either by way of deduction of points or otherwise – as it may think fit.
