BALLOT: A ballot will be held.

First Draw: All eligible members (ie Full, Intermediate and Junior

members aged 9 and older) and Life Members. **Second Draw:** All other eligible members.

First preference in each draw will be given to members who have not had tickets in the previous 2 years, and second preference to those

who did not have tickets in the previous year.

FAMILIES: All eligible members of a family are treated individually, ie they all

have an equal chance under the above system of receiving a pair of tickets. If more than one member in a family is lucky in the draw, you will only be allocated one pair of tickets, in the name of the first person drawn, unless you indicate otherwise on the application form. If you need additional copies of the application form over-leaf, please

IMPORTANT NOTES:

Please show clearly your preferences, as this will be taken into account literally during the allocation process. Preference can only be given to day not court preference with tickets available for Centre Court, No 1 Court and Court No 2.

Please return the form by Friday 3 April 2020, as the draw may be undertaken immediately after that date.

In the case of Juniors (aged under 16) who apply for and receive tickets they must attend and be accompanied by a responsible adult when he/she attends Wimbledon. Only Junior Members aged 11 and above may apply.

By applying for Wimbledon tickets you agree that your name and county may be made available on request.

Tickets are not transferable and can only be used by the actual person who applied for them, plus one other guest. They must be returned to the Club for reallocation if they cannot be used by that person. This rule will be strictly enforced, as it is an LTA requirement, and also ensures fair allocation, year by year, within the Club.
