General Data Protection Regulation 2018 (GDPR)

All organisations holding personal information about individuals are required to comply with this regulation. This means that we need to obtain the explicit consent of members to store their personal data and to use it for purposes concerned with running the club.

Goring Tennis Club membership data is organised by family – where a family may be a single individual or one or more adults and children living at one address. Every family has at least one adult member, who may be a non-playing adult as a parent of the family's junior member(s). Members join by family and annual membership renewal is by family. We ask you, in applying for family or individual membership of Goring Tennis Club, to give your consent by completing the consent form at the bottom of this page.

The information we hold on your family is mainly the information you supplied on the membership application form, with any updates you may subsequently provide. We also hold membership renewal status which is updated as subscriptions are received. The only other information we may hold is Wimbledon ballot opt-in status obtained from British Tennis. We store your data securely on password protected computers.

We use the data we hold only for activities directly related to the operation of the club:

- a) Performing those operations essential to managing your family's membership of the club, including calculating your family membership renewal subscriptions each March, sending you a renewal email and processing payments.
- b) Sending you emails relating to club activities that may interest you.
- c) Including the names and contact details of adult playing members in a contact list of all adult members which is distributed to all adult members and also deposited in the clubhouse.

In giving your consent you may exclude the uses b) and/or c).

We do not share your data with any external organisation except Oxfordshire Tennis Ltd. Oxfordshire Tennis Ltd is our coaching provider. We share membership data with them for use only in the provision of coaching to members of Goring Tennis Club, including offering coaching opportunities to members by email. Oxfordshire Tennis Ltd does not share any data provided by Goring Tennis Club with any third party.

Transparency. You are reminded of the information we hold about your family in your renewal email each March, but you may also ask the membership secretary for a copy of this at any other time. We are now asking for your consent to us storing and using your data, but you can withdraw this consent at any time by asking the membership secretary. When a member ceases to be a member we hold their data for 7 years to be in compliance with tax regulations, then delete it. During this period we do not use your data in any way.

Junior data. Junior data will receive additional protection, not appearing on any general list. Any photographs of children will be used on the club website or in connection with publicity for Goring Tennis Club only with the explicit permission of their parents.
