Grounds Report – James Marchant

To support Marc's team, in their non-coaching hours they have been running the day-to-day grounds-keeping in 2020/1.

Activities:

- Following the astro installation of court 5 in 2019, there has been no requirement for major works this year.

Ongoing maintenance:

- I have made sure that the club is maintained to its current standard. If there are any members who have the time to work on improvement projects, including planting bulbs and flowers in the court surrounds: pls. contact me.
- The courts will be deep cleaned externally three times this year and we rely on the efforts of members to keep the courts clean and clear of any litter and fallen leaves and seeds.
- I am aware the lights token box has been erratic. If it continues or gets any worse, it will need to be looked at by the manufacturers (based in Sussex). I have not

4). Social Report – Maddy Marley

Lock downs due to Covid greatly affected social play March 2020 – March 2021.

We shut the courts on 26th March 2020 and reopened them for summer social play on Tuesday 28th July 2020 on Tuesdays 18.00-21.00 (all courts) and Saturdays 14.00-17.00 (all courts apart from Court 2, 2-3pm). We were fully compliant with LTA guidelines for social play:

- providing hand sanitizer across the premises
- permitting club house to be used for toilets only, no further congregation
- social distancing outside the clubhouse whilst waiting for court play
- recording attendance by paper register (and later WhatsApp) -
- using own balls instead of offering club balls-
- preventing adjusting nets by removing handles
- bringing own drinks along.
- no permitted use of clubhouse for coffee and tea making, and no cakes provided for social play.

There was no evidence of catching Covid from Grove social play, indicating that these measures were effective.

When the clocks went back in October, social play hours changed on a Saturday, to 13.00-16.00, and on Tuesday evenings courts 3,4 and 5 were made available. Social play continued, in the place of Winter League, with lighting tokens available at no extra cost.

Another lock down followed 5th November – 2nd December, during which social play was banned. We were permitted to continue play during December in Tier 3, until Boxing day at which time we went into Tier 4, and then into lock down again on 5th January 2021. At the time of writing we are still in lock down, with no social play allowed.

According to the LTA restrictions will be lifted from 29 March onwards – we hope. Social play is about to resume around that time.

Throughout the year the social players kept in touch with each other via the popular Social Tennis WhatsApp group. This was especially useful for introducing new members, organizing your own games, gauging attendance on poor weather days and advertising social tennis times. A blackboard, suitable for indoor and outdoor use was also purchased for similar advertising. A Social page was added to the Grove Website under the 'More' heading, in preparedness for future event advertising, and we are pleased to now have Krystyna who has volunteered to keep the website up-to-date.

Attendance was below normal for all social sessions.

5). Matches and Tournaments secretary's report – William Freeman

The Government's published roadmap for the easing of lock down restrictions confirmed that outdoor tennis courts will be able to open from 29 March, though this may still be subject to additional restrictions and protocols, as stated in the LTA Summary Grid: Covid 19 restrictions. With this in mind we have provisionally entered 4 Ladies, 3 Men and 3 Mixed in the Cambridge League and 2 Ladies and 1 Men in the Essex Summer Cups.

The latest guidelines do not allow spectators and as our internal competitions; the club tournament, the Briscoe Cup (Mixed Doubles), Charles Hassell Cup (Ladies Doubles) and Wallis Cup (Men's Doubles) go hand in hand with a social event. I propose waiting until more restrictions are lifted before arranging them.

The 2020 season was devastated by Covid and all internal and external tournaments were cancelled. In autumn, an attempt to run a one off 2020 Celebration League based on the existing Men's and Ladies was curtailed with 85% of matches played which sums up how Covid has disrupted our tennis.

One piece of good news was the introduction TennisRungs a ladder system for singles and doubles and by the end of the year over 60 members had signed up. Thanks to Simon McInnes for organising this and this has provided a very popular competitive alternative to inter-club matches. You can join the ladder from the website.

Lastly I would like to acknowledge the hard work and dedication of Debbie Bowes and Paul Kent who both retired from their respective Captain's roles in 2020. They left the club in a strong position and our next challenge is for the incoming Captains Kirsty Rowlandson and Adrian Holley to maintain our position.

10). Coaching report – Marc Squire

What a difficult year for everyone!

After the first lock down the coaching team got back on court on the 18th May but we were only able to carry out 1 to 1 lessons no groups were allowed. (£106.50 non-member fees raised in the summer term). We were able to run 3 weeks of summer camp but we had to change how we usually run the camps which meant less children could attend (£640 was raised with non-member fees). In September group coaching recommenced (8th Sep to 4th Nov then we had lock down and we could continue 2nd December to 19th December. (£729 raised with non-member fees). Due to the lock down in January we were unable to complete the courses but this will be done after this lock down. During the Autumn period we ran 9 adult groups and 14 junior groups (£246 for floodlights was paid on 20/12/20). Adult group coaching is on the whole pay and play (using izettle) now, due to covid, groups are now using WhatsApp which has really helped with the sign-up process. (max group number for 1 coach is 8 using 2 courts).

Unfortunately the coaching team have only been able to work 29 weeks since April but hopefully from this April things will start to go back to some sort of normality.

11). Proposals for AGM from the Committee

1. Older juniors (12 yrs and above) should be able to book Court no. 2. This can be done on ClubSpark

There are some restrictions on those bookings:

- can be made within time windows (TBD)
- maximum 3 days ahead
- not during social evenings

THIS would NULLIFY the present rule for ‘priority for juniors on Court 2’ which is confusing to all

2. Membership fees for 2021/2 season

We will maintain the same membership fees as in 2019... ie NO Increases.

3. Guardian membership

During Covid Guardian members were able to book a court, but this has to revert to original conditions. See website membership for details.
