*Our club year runs from 1st April to 31st March. If you join LTC before 1st October, the full fee will apply.

If you join after 1st October, then 50% of the membership fee will apply.

Conditions of membership:

- 1. By applying for membership, each member (and/or the parent/guardian applying on their behalf) agrees as a condition of membership to be bound by and subject to the rules & regulations of the Club, the rules & regulations of the Surrey County LTA and the rules & disciplinary code of the LTA.
- **2.** Applicants also recognise and accept that the club is a 'company limited by guarantee' and, as such, they (or their parents/guardians) will automatically become members of Leatherhead Tennis Club Limited and have a potential liability of £1 should the Company become insolvent.

The full version of the club's Rules is available from the website (home > about us > club rules) The following summarises key aspects of each type of membership

ADULT MEMBERS: have the use of the clubhouse and tennis courts at all times, except as otherwise directed by the Committee; the right to vote at General Meetings and to hold office if elected.

YOUNG ADULTS are age 18 - 25 inclusive on 1st April in the year they join or renew their membership. **STUDENT MEMBERS:** are aged 18 - 25 on the 1st April as above, proof of being in full time education is required and they must live away from home. Both categories have the privileges of Adult members.

JUNIOR MEMBERS: are under 18 on the 1st April in the year they join or renew their membership and are admitted at the discretion of the Committee. They have the use of the facilities at such times as determined by the Committee and noted in the clubhouse/website. Juniors have no right to vote at General Meetings or to hold office. Juniors may not book courts after 7pm Monday to Thursday or before noon Sunday mornings, but may have the use of them when not booked by adult members. **Junior Supplement Forms must be completed for each Junior member and returned in hard copy to the Membership Secretary (address details below). Forms available on the website.**

Parents/Guardians please note: When dropping off your children at the club to play tennis you must be aware that, *unless it is a supervised club session or lesson*, your children will be unsupervised. Even if there are adults playing on court when you drop your child/children off it is not their responsibility to supervise your child / children. The adults may leave at any time leaving your child alone. Please make sure that if dropping your child off to play with a friend you are happy for them to be at the club **alone**, if this is not the case you must provide supervision.

JUNIOR PARENTS: who have paid the 'junior parent' subscription have the right to play tennis with their own junior member children only, within the times stated in Junior Membership.

MINI TENNIS MEMBERS: must be aged under 11 on the 1st April in the year they join or renew their membership. Court usage is only with mini tennis balls and times of play are restricted to before 6pm Monday to Friday and after 6pm on Saturdays and after 1pm on Sundays.

MINI TENNIS PARENTS: who have paid the 'mini parent' subscription have the right to play mini tennis with their own children, who must be mini tennis members, within the times above with mini tennis balls only. Junior and adult tennis balls should not be used by mini tennis players or their parents.

SOCIAL MEMBERSHIP: is available to former playing members, spouses or partners and others who may wish to be associated with activities arranged by the club. Social Members are eligible to attend social functions and may represent the club in non-tennis competitions. They do not have voting rights at AGMs but they may hold office if elected. Social members may play tennis up to 6 times a year, without introduction by a playing member, on payment of the visitors' fee.

TEMPORARY MEMBERS: (Please apply to the Membership Secretary for rates) will be for people moving into the area for a short time only. They have the use of the clubhouse, tennis courts and social sessions (subject to their grading) during their period of membership, except as otherwise directed by the Committee.

CLUBHOUSE AND GROUNDS: Members and guests must take good care of the clubhouse and grounds. They must comply with the conditions relating to the issue of keys and ensure that club property is kept secure, especially when they are the last to leave. Parents and guardians must follow the Junior Access Policy.
