## **Terms & Conditions**

By joining the Somer Valley Tennis, you agree to the following terms and conditions.

I hereby agree to be bound by the club's constitution, the main points of which are listed below (full constitution available on the website)

- Membership will be granted upon payment of the required fee for the appropriate period
- Neither The Club, nor Dragonfly Leisure (as Court Owners) accepts any responsibility for personal injury or loss of or damage to property on or in the vicinity of the tennis court. Persons using the court do so at their own risk.

#### Membership

- Somer Valley Tennis operates a FIXED term membership which is paid on 1<sup>st</sup> April each year and is valid for one year from 1<sup>st</sup> April 31<sup>st</sup> March. Upon joining or renewing, all members must pay the correct fee according to their membership category and payment method.

- If a person joins part way through the membership year, then a reduced charge will be paid, this will be for the period up to and including 31<sup>st</sup> March the following year.
