Notes:

1) Subscriptions become due on 1st April 2024. Members renewing after 30th April 2024 will be considered to be rejoining and will be liable to pay the joining fee.

2) Joint Membership is available to all co-habiting partners.

3) Youth Membership and Student Memberships are available to any member aged 18-25 inclusive. Student Members also need to be in full-time education

4) Off-Peak Members are allowed to play up until 18:00, Monday to Friday inclusive and after 18:00 on Sundays

- 5) Social Affiliation provides access to the club's social facilities, the bar, social events, barbecues etc. Social affiliates are not entitled to play tennis, enter the Club Wimbledon ballot, participate in the AGM or stand for election to the Committee.
- 6) Age limits apply as at 31st December 2023 and do not include the limit (e.g. "Under 11" means up to and including 10).
- 7) Family Junior Membership is available to juniors having at least one parent as a Full Member.
- 8) Junior Membership: Due to our obligations under Child Protection Regulations, we need to maintain records of one parent of a Junior Member. These details will be stored on the Tennis Club database and the parent will be classified as a Social Affiliate but there is no charge.
- 9) Members with over 50 years of consecutive playing membership may apply for Life Membership. Such applications will be subject to approval by the Committee. Such applications are in addition to those proposed by the Committee and ratified at an AGM.
- 10) Young Adult Membership is available to any member aged 26 to 32 inclusive.
- 11) Family Memberships are available to any Full or Joint Members who have 2 or more Junior Playing Members who qualify for the Under 11 or Under 18 Membership Categories. They are priced at Full/Joint Membership plus 2 Under 11s.
- 12) Single Payment is the Total Payment (plus the Joining Fee if applicable see Note 1). Complete this column or the columns noted 14).
- 13) Staged Payments are available provided at least one Member is Full, Joint, Young Adult, Youth or Off-Peak and equates to one upfront payment plus three recurring equal value payments. There is an administration charge for this payment method which is included in the upfront payment (£15 for Joint, £10 for Full and £5 for Young Adult, Youth and Off-Peak),
- 14) Upfront Payment is the Upfront Payment (plus the Joining Fee if applicable see Note 1) and the Recurring Payment is the Recurring Payment if you have selected this payment method.
- 15) Trial Membership lasts for a 6 week period, can be applied for between April and July and applies to Full, Joint, Young Adult, Off-Peak and Family Membership categories. Prices available upon request.
