TERMS AND CONDITIONS AS AT 12th February 2025

MEMBERSHIP

1. Payment and uptake of *Ifield Tennis Club* Membership implies acceptance of our Terms and Conditions.
2. If accepting the Terms and Conditions of *Ifield Tennis Club* as a parent/carer on behalf of a junior member, all clauses apply to their membership.
3. Annual membership runs for 12 months from date of purchase and is to be paid in full. Payment can be made by bank transfer, cheque or cash. Cash or cheque payments will need to be handed to a member of the Committee on site.
4. Annual Parent Membership – this membership can only be purchased in conjunction with Annual Junior Membership. The parent will be a key holder and can accompany a junior to play at the club outside of the weekly organised junior session by booking a court in the normal way. The junior must be supervised at the club at all times.
5. Your membership cannot be cancelled during this period irrespective of a change to your personal circumstance.
6. A set of keys for the club can be issued with the following membership packages:
Annual Adult Single
Annual Adult Couple
Adult Single Summer
Annual Parent membership
2 month trial membership
Once payment has been received for your chosen membership package, a £30.00 refundable cash deposit will be required before issue of keys. This cash deposit will be returned in full once the keys are returned in person to a committee member should you cancel/not renew your annual membership, or at the end of a Summer Membership.
7. If your keys are lost a fee of £10.00 will be charged for a replacement set.
8. Membership and keys are NOT transferable and must only be used by the registered member. Any misuse of membership or keys will result in the membership being cancelled.
9. In accordance with our lease agreement all persons using *Ifield Tennis Club* must be members. However a member can bring a guest to visit and play at the club a maximum of 3 times, we request a nominal fee of £3 per visit. Once the guest visit limit has been reached the guest will be required to take up a membership package paid in full.
10. Membership entitles the member use of the club facilities.

COURT USE

1. To use a court outside of organised club sessions please use the Court Booking module on the website. If you are using a court without advance booking and a member arrives who has a confirmed booking you will be required to leave the court.
2. Suitable clothing and shoes should be worn on court.
3. Players should not enter the court area if the courts are icy or slippery.
4. Members declare that, to the best of their knowledge, they are medically fit to play and will not play against medical advice.

CLUB HOUSE USE

1. Members have access to the club house and access to the disabled toilet in the Community Centre – access to the toilet will be explained in person to you by a committee member. When the centre is open we need to be respectful to the partners using the main facility.
2. Please respect the club house and leave it clean and tidy.
3. If you are the last to leave the site please ensure that all the doors and gate are securely locked.

FEES AND CHARGES

1. The membership fee stated is due from the member to *Ifield Tennis Club* and is payable upon inception of this agreement. Any portion of the membership fee will only be refundable in the event of us being unable to provide you with the membership services for a significant period of time. Such refund would be calculated on a pro-rata basis to the break in services experienced and will not apply to circumstances which are outside the control of *Ifield Tennis Club* (such as enforced closure due to the Covid-19 pandemic).
2. *Ifield Tennis Club* review the pricing of membership on an annual basis.

LIMITATION OF LIABILITY

1. *Ifield Tennis Club* will not be liable for any loss, damage or theft of personal property brought onto the premises.
