Treasurer report for the period 1 April 2022 to 31 March 2023

Please find attached the financial statements for the club for the period 1 April 2022 to 31 March 2023.

The club recorded a profit of £47,921 following the previous year's profit of £28,007. This is a welcome result as it comes during a period of rising costs and ahead of the planned resurfacing of the hard courts and the purchase of the bowling green land. Membership income was £25,914 higher than the previous year and bar sales increased by £10,301. As expected, expenses were higher, not helped by a near doubling of our energy costs, but overall, they were contained.

Following the court resurfacing and land purchase, it is anticipated that our cash reserves will fall to around £290k which will be used to turn the newly purchased land into courts and the resurfacing of the artificial clay courts that is due sometime in the next 5 years. This will reduce our cash reserves significantly and we will need to rebuild our reserves accordingly. Our previous cash forecasting work suggests that we should aim for £35k annual profits which is not dissimilar to what has been achieved over the last three years, so I am confident that this can be achieved without major changes to our membership fees or bar pricing.
