

YOU ARE INVITED TO JOIN OUR 100 CLUB!

Joining the Sodbury TC 100 Club is a great way for you to support our aim to improve the club facilities whilst having a bit of a flutter! To take part, there are just three simple steps to follow:

Step 1. Read the 100 Club Rules (see Page 2).

Step 2. Email Treasurer <u>Paul</u> and 100 Club Coordinator, <u>Tony</u> (TC) to let them know you would like to join the 100 Club, stating how many lottery numbers you wish to purchase. *You must also state in your email that you have read the 100 Club Rules.*

Step 3. Once you have emailed Paul and Tony, make your 100 Club lottery payment.

It costs £25 per 100 Club membership number which is valid for a one-year period and you can purchase a maximum of four numbers. Payment can be made via a bank transfer to Account Name: The Sodbury Tennis Club 100 Club; Sort code 52-21-32; Account Number 25461230. It is also possible to pay via cheque.

Once your 100 Club lottery payment is received, we will allocate and email you, your 100 Club membership number(s). You are now ready to take part in the monthly draw!

The draw will take place on the last Friday of each month.

Monthly winnings will either be paid into the lucky winner's bank account, alternatively, a cheque may be issued, or monies provided in cash. The name of the winner will be published on the Club's website and Facebook page.

FAQ's

A. What is the Sodbury TC 100 Club? It's a private society lottery. Members of Sodbury TC who are aged 16 or over are invited to participate, as are parents of Members aged under 16 years of age.

B. How many numbers can I buy? Up to four numbers per year.

C. How much does it cost? A number costs £25 per annum; Members buy their number(s) for a one-year period.

D. How do I pay? Payment for the year (£25 per number) is to be made via a BACS transfer or cheque. Bank account details are: Account Name: The Sodbury Tennis Club 100 Club; Sort code 52-21-32; Account Number 25461230

100 CLUB RULES 2019

PURPOSE

The purpose of the 100 Club is to raise funds to purchase equipment for the Sodbury TC clubhouse and other associated resources to improve the club's facilities. Monies received by the 100 Club will be paid into the Sodbury Tennis Club 100 Club bank account.

RULES

- 1. The 100 Club is a private society lottery and is open to all members of Sodbury TC who are aged 16 or over plus parents of members aged under 16.
- 2. As a private lottery you are invited to join and will be allocated a number / numbers.
- 3. Your number(s) are not transferable.
- 4. For a cost of £25 per year (approx. £2.10 per monthly draw) and on receipt of payment, you will be allocated one number between one and two hundred.
- 5. Members may apply for a maximum of four numbers.
- 6. Payments must be made annually, *in advance of the draw*.
- 7. Members will be sent their number(s) via email.
- 8. A draw will be made every month and there will be one prize winner per month. The draw will be conducted by a committee member in the clubhouse on the last Friday of the month.
- 9. The total prize money will be 48% of the monthly income except for December when the prize money will be £200.
- 10. The remaining 52% of monies raised from the 100 Club will go towards funding club maintenance and improvements. In 2019 monies raised will be used to help fund the club's general facilities.
- 11. Monthly winners will either have their winnings transferred to their bank account within one week of the draw or be issued a cheque or paid in cash.
- 12. The name and numbers for each month's winners will be posted on the club website and Facebook page.
- 13. The 100 Club will be run by the Sodbury Tennis Club Committee. In case of any dispute the decision of the Committee is final.
- 14. The Club reserves the right to alter the rules of the 100 Club from time to time as maybe necessary
- 15. Participants can cancel their entry in the lottery at any time by giving one month's written notice to the treasurer.
- 16. Unless otherwise advised, a member will be deemed to have left the 100 Club if his/her annual subscription renewal remains unpaid for a period of one month.
- 17. Member's number(s) will only be entered if their annual subscription is up to date.
- 18. If a member has no valid reason for missing their annual payment, their number may be sold to someone else.
- 19. Any decision by Sodbury Tennis Club to wind up the 100 Club will also be by one month's written notice. Under no circumstances can any payments be refunded.
